In January of 2011, the Safe Water Drinking Act (SWDA) Section 1417 was amended to reduce the amount of lead in pipes, plumbing fittings or fixtures, solder, and flux. The Act established an effective date of January 4, 2014 to allow a timeframe to transition to the new requirements and to install any existing stock into water systems. This amendment was established in order to reduce/eliminate the amount of lead in drinking water linked to cause serious health issues in adults and developmental problems in newborns and infants.

The Department of Public Works has a surplus of leaded brass plumbing fittings and fixtures that will not be able to be installed into the water system by the effective date of January 4, 2014. The Department also has a large quantity of water meters that have been removed from the distribution system over the past few years via the change-out program and/or meter upgrades that are ineligible to be reused due to the lead content in the brass.

The Underground Utilities Division has stripped and separated the meters, fittings, and fixtures of all recyclable parts and has received pricing for scrap of the remaining leaded brass. The circuit boards of the water meters will be environmentally recycled along with the leaded brass.

In previous years the recycled water meters have been sold as scrap to vendors as whole meters at a lower rate. With the meters stripped of all parts, a higher scrap value will be gained. Below are quotes for scrap value of the brass:

Brass has different classifications for recycling. Red brass is "cleaner" or only brass, and yellow brass has some other trace metals/plastics included. Since our meters were stripped, they are considered red brass. Acme Refining chose not to bid due to the fact they wanted to inspect all of the brass at our cost and would not commit to pricing without inspection.

2010 was the last time meters were recycled/scrapped with the following pricing with current meter stock quantities:

There is a significant difference in revenue for stripping meters in-house than selling complete meters for scrap as shown below:

Stripped Meters: \$2,257.00
 Complete Meters: \$851.00
 Difference: \$1,406.00

Due the nature of the scrap metal industry, brass pricing will fluctuate day by day. However, the pricing for brass has been holding steady with only a small fluctuation in price. The revenue gained from the sale of the meters will be deposited in the Water & Sewer Operating Fund Revenue Meter Sales account (510.61520).

I am recommending the Board of Trustees declare the unused water meters, fittings, and fixtures in Public Works inventory surplus and give Public Works the authority to recycle/scrap the water meters to the highest bidder, Redline Metals of Lombard, IL. Please submit this recommendation to the Board of Trustees for their approval at the December 5, 2013 meeting.
