A RESOLUTION OFFICIALLY RECOGNIZING THE PROPERTY LOCATED AT 115 E. ST. CHARLES ROAD AS THE HAMMERSCHMIDT PARKING LOT

WHEREAS, William Hammerschmidt's father, Adolph, was born in Germany in 1827, came to America in 1848, and was the first of the family to make DuPage County "home" and

WHEREAS, in 1878 William Hammerschmidt, a young man of twenty-four, came with his father from Naperville and bought a clay pit where the Hammerschmidt School later was built; and

WHEREAS, William Hammerschmidt relocated the Lombard Brick and Tile Company to the north side of the Union Pacific railroad tracks; and

WHEREAS, in 1926 a battery of coal silos were built along St. Charles Road for a cost of \$30,000; and

WHEREAS, in 1935 the business name was changed to Hammerschmidt Lumber and Fuel Company; and

WHEREAS, William Hammerschmidt was a supervisor of York Township for twenty years and also filled various local offices and contributed much in the field of education; and

WHEREAS, the Village of Lombard has completed the construction of a commuter parking lot at the property commonly known as 115 E. St. Charles Road and legally described as follows; and

LOT 2 OF THE ST. CHARLES CORRIDOR REDEVELOPMENT PLAT OF RESUBDIVISION, BEING A RESUBDIVISION OF BLOCK 15 AND BLOCK 16 OF THE ORIGINAL TOWN OF LOMBARD, A SUBDIVISION OF SECTIONS 5, 6, 7, AND 18 IN TOWNSHIP 39 NORTH, RANGE 11 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED APRIL 25, 2005 AS DOCUMENT NUMBER R2005-083483, IN DU PAGE COUNTY, ILLINOIS.
