

ORDINANCE NO. 4612

AN ORDINANCE AMENDING TITLE 3, CHAPTER 30 OF THE LOMBARD VILLAGE CODE IN REGARD TO VILLAGE BOARD MEETINGS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 3, Chapter 30, Section 30.01 of the Lombard Village Code is amended by revising the first sentence thereof to read as follows:

"Regular meetings of the Board of Trustees shall be held on the first and third Thursday of each month at 7:30 p.m. in the Board Room of the Village Hall."

SECTION 2: That the Village Clerk is hereby directed to advise all media, that have requested notice of the time and place of Village meetings, of this Ordinance. In addition, pursuant to 5 ILCS 120/2.03, the Village Clerk is directed to publish a notice of the additional meeting date set forth in Section 1 in a local newspaper. Said notice shall be in the form attached hereto as Exhibit "A" and made part hereof.

SECTION 3: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
