

ORDINANCE NO. 5197

**AN ORDINANCE CORRECTING ORDINANCE 4965
VACATING OF A PORTION OF ANN STREET
AND ELIZABETH STREET RIGHTS-OF-WAY**

WHEREAS, on May 3, 2001, Ordinance 4965 was adopted by the President and Board of Trustees of the Village of Lombard which vacated a portion of Ann Street and Elizabeth Streets; and,

WHEREAS, an incorrect legal description was provided to the Village as part of said Ordinance; and

WHEREAS, a correct legal description is necessary to effectuate the approval and recording of the associated Plat of Vacation.

NOW, THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

SECTION 1: That the legal description included as part of Section 2 of Ordinance 4965 is hereby corrected as follows:

That this ordinance is limited and restricted to the following described right-of-way:

THAT PART OF THE ANN STREET RIGHT OF WAY LYING EAST OF THE SOUTHERLY EXTENSION OF THE WEST LINE OF SAID LOT 24 IN BLOCK 11, AND LYING WEST OF THE SOUTHERLY EXTENSION OF A LINE 47.22 FEET EAST OF THE WEST LINE OF SAID LOT 15 IN BLOCK 6 IN ROOSEVELT CREST SUBDIVISION; AND

THAT PART OF THE EAST 1/2 OF THE ELIZABETH STREET RIGHT OF WAY LYING WEST OF AND ADJACENT TO THE WEST LINE OF SAID LOT 7 IN BLOCK 5 AND THE WEST 1/2 OF THE ELIZABETH STREET RIGHT OF WAY LYING EAST OF AND ADJACENT TO SAID LOT 1 IN BLOCK 12, LYING NORTHERLY OF THE SOUTH LINE OF VACATED 20' ALLEY, AND LYING SOUTH OF A LINE DRAWN FROM A POINT ON THE EAST LINE OF SAID LOT 28 IN BLOCK 11, 58.35 FEET SOUTH OF THE NORTHEAST CORNER OF SAID LOT

TO A POINT ON THE WEST LINE OF SAID LOT 15 IN BLOCK 6, 58.35 FEET SOUTH OF THE NORTHWEST CORNER OF SAID LOT, IN ROOSEVELT CREST SUBDIVISION.

SECTION 2: That all other provisions of Ordinance 4965 shall remain in full force and effect.

SECTION 3: That this ordinance shall be in full force and effect from and after its passage and approval as provided by law.


