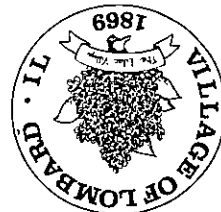

Please be advised Blazin Wings, Inc. d/b/a Buffalo Wild Wings Grill & Bar located at 207 E. Roosevelt Road originally requested a Class A/B II liquor license. After reviewing their projected alcohol sales, it is expected that their alcohol sales will exceed \$400,000.00 yearly which will categorize Buffalo Wild Wings into a Class A/B III liquor license. I have reviewed this request with Trustee Soderstrom and he also approves said liquor license change.

ORDINANCE
AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B II" liquor license, contained therein, to read as follows:

Class "A/B II" - 9

This decrease in Class "A/B II" liquor license reflects a classification change to Blazin Wings, Inc. d/b/a Buffalo Wild Wings Grill & Bar located at 207 E. Roosevelt Road, Lombard.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B III" liquor license, contained therein, to read as follows:

Class "A/B III" - 17

This increase in Class "A/B III" liquor license reflects the issuance of a Class "A/B III" liquor license to Blazin Wings, Inc. d/b/a Buffalo Wild Wings Grill & Bar located at 207 E. Roosevelt Road, Lombard.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
