Hotel/Motel Grant Recommendations

The Community Promotions & Tourism Committee met on September 20, 2012 and reviewed two hotel/motel tax grant applications. The grant requests and accompanying recommendations are provided below for your consideration.

### 1. Grant Request for Glenbard East Booster Turf Stadium Project

A request from the Glenbard East High School Boosters was submitted for consideration to help fund the marketing efforts of an upcoming concert. The concert is a fundraiser for the turf field project. The grant application and supporting documentation is attached as *Exhibit 1* for your review.

#### HISTORY

This is the first grant request considered from the Glenbard East High School Boosters.

#### **RECOMMENDATION:**

The Community Promotion & Tourism Committee recommends awarding the Glenbard East High School Boosters a grant not to exceed \$2,500 to be used for costs associated with marketing the upcoming American English concert at Biester Auditorium on the Glenbard East campus.
