Village staff has been notified that more than fifty percent (50%) of the ownership interest of T.G.I. Friday's Inc. located at 601 E. Butterfield Road, will change pursuant to a closing on July 15, 2014. Village Code requires that a liquor license shall terminate whenever fifty percent (50%) or more of the ownership interest changes from the original license application.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor license category, contained therein, to read as follows:

Class "A/B-III" - 14

This decrease in the number of Class "A/B-III" liquor licenses reflects the termination of the Class "A/B-III" liquor license issued to T.G.I. Friday's, Inc. d/b/a T.G.I. Friday's #0063 located at 601 E. Butterfield Road, as a result of a change in the ownership of T.G.I. Friday's Inc., involving more than 50% of the ownership interest.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor license category, contained therein, to read as follows:

Class "A/B-III" - 15

This increase in the number of Class "A/B-III" liquor licenses reflects the issuance of a new Class "A/B-III" liquor license to T.G.I. Friday's, Inc. d/b/a T.G.I. Friday's #0063, located at 601 E. Butterfield Road.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
