BE IT ORDAINED, by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That pursuant to Section 5/11-80-19 of Chapter 65 of the Illinois Compiled Statutes, the name of Lancaster Court is hereby changed to Kufrin Way.

SECTION 2: This change in name shall not be effective until thirty (30) days after the election authorities having jurisdiction in the area in which the name of Lancaster Court is changed and the post office branch serving said area have been notified by this Board in writing by certified or registered mail


SECTION 3: The Village Clerk is authorized and directed to provide such notice to said election authorities and post office branch.


