At the June 19, 2023, meeting of the Plan Commission, the Plan Commissioners considered a petition to approve construction of a new parking lot on 999 N. Garfield Street for the off-site parking use of IMG Trucking Inc. located at 1051 N. Garfield Street. The Plan Commissioners voted to recommend approval of the petition as presented to the Plan Commission. Community Development staff planned to transmit this item to the Village Board for consideration at the July 20, 2023, meeting.

Following the Plan Commission public hearing, the petitioner informed Community Development staff that the owner of 999 N. Garfield Street intends to revise the proposed site plan. The revised plan includes a newly proposed cross access driveway on the north property line between the subject properties' parking lots. Staff determined that the proposed changes are major changes, and require a new public hearing with the Plan Commission.

ACTION REQUESTED
