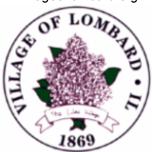

IX. Items for Separate Action

Ordinances on First Reading (Waiver of First Requested)

*A. 120676 Ordinance Amending Title 3, Chapter 31 of the Lombard Village Code in Regard to Village President (Tabled January 3, 2013) Revising Title 3, Chapter 31 of the Village Code in regard to the

selection of a President Pro-Tem and Temporary Chairman.

Acting President Bill Ware indicated that he had met with Village Attorney Tom Bayer and asked for further clarification on the proposed ordinance.

Village Attorney Tom Bayer indicated that the proposed ordinance appoints a President Pro-Tem and Temporary Chairperson if there were a vacancy.

Trustee Breen noted that he had attended the DuPage Mayors and Managers Conference meeting the night before and had spoken to Mayors with regard to this proposed ordinance. He spoke of the situation with West Chicago Mayor Mike Fortner who was elected to the position of State Representative and the smooth transition that followed after the appointment. He spoke of the former Mayor of West Chicago who had passed away suddenly. He indicated there was movement to change State law with regard to this matter and how it

may takes years to get this change adopted. He spoke of the embarrassment of the Village Board when they were going through the process of selecting an Acting Village President after the death of President Mueller. He stated he hopes that it never happens in the Village again where a replacement is needed, but if that does occur, he felt having a plan in place for the appointment was necessary. He felt it was the current Village Board's job to have a policy in place. Trustee Giagnorio indicated that the problem was with the split Board and voting.

Village Attorney Bayer stated the ordinance, if adopted, would take effect after the new Board is sworn into office.

Trustee Breen spoke of the idea of selecting a Trustee to serve as Acting Village President if the President were unable to attend a meeting instead of defaulting to the senior trustee.

Trustee Giagnorio stated he wanted the residents to know that this proposed ordinance was not a cure all.

Trustee Giagnorio moved that the proposed ordinance be tabled to the first meeting in June so that the new Village Board could review this and make a decision. He did not feel that it was fair to saddle a new Board with a policy that they had not given their input on with regard to the selection of an Acting Village President.

A motion was made by Trustee Keith Giagnorio, seconded by Trustee Greg Gron, that this Ordinance be tabled to the first meeting in June. The motion failed by the following vote:

Ave: 3 - Greg Gron, Keith Giagnorio, and Bill Ware

Nay: 3 - Zachary Wilson, Peter Breen, and Laura Fitzpatrick

Trustee Fitzpatrick felt that what the Village Board has in place is broken and that this needed to be fixed. She felt that the most tenured person may not be the best person to take over as Acting Village President. She spoke of Trustee Ware not being the most tenured nor the least tenured. She spoke of making a choice before emotions are involved in the selection process and before the need arises. She felt waiting was not a good choice and felt the Village Board should make a decision.

Trustee Wilson felt the Board would not change dramatically after the upcoming election.

Trustee Breen moved that a selection of an Acting Village President be made with sixty (60) days following each election. A motion was made by Trustee Peter Breen, seconded by Trustee Laura Fitzpatrick, that this Ordinance as proposed to select an Acting Village President within sixy (60) days following an election, be waived of first reading and passed on second reading with suspension of the rules. The motion failed by the following vote:
