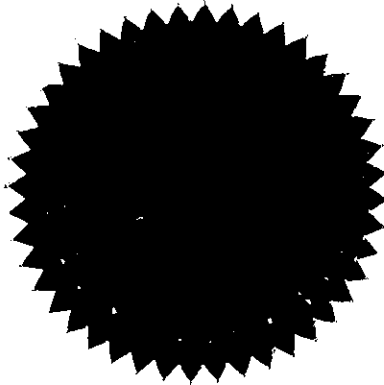

**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule IV of the Lombard Traffic Code (Ordinance 1186) entitled STOP STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>Shall Stop At</u>	<u>Name of Street</u>
Brewster Ave.	“	Hickory Street
Hickory Street	“	Edson Ave.
View Street	“	Edgewood Ave.

Section 2: That Schedule V of the Lombard Traffic Code (Ordinance 1186) entitled PREFERENTIAL STREETS be amended to delete the following therefrom:

Hickory Street will yield to Edson Avenue

View Street will yield to Edgewood Avenue

Section 3: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Garfield Street West side	740 feet north of the north curb line of Progress Road	a point 1285 feet north

Section 4: That Schedule XV of the Lombard Traffic Code (Ordinance 1186) entitled RIGHT TURNS ON RED TRAFFIC SIGNALS be amended to add the following thereto:

Westbound North Avenue shall not turn on red onto Main Street.

Section 5: That Schedule XV of the Lombard Traffic Code (Ordinance 1186) entitled RIGHT TURNS ON RED TRAFFIC SIGNALS be amended to delete the following therefrom:

Westbound North Avenue shall not turn red onto Main Street between the hours of 12:00p.m. to 1:00 p.m. and 4:00p.m. to 6:00p.m. on Monday through Friday.

Section 6: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.


