ORDINANCE NO. 6622

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES AND THE CLASS "N" LIQUOR LICENSE CATEGORY

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by relabeling the Class "N" liquor license description as Class "N-I" and adding language to the end of the description as follows:

"Gross annual dollar amount of liquor sales of more than \$300,000.00."

SECTION 2: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class "N-II" liquor license category, to read in its entirety as follows:

"Class "N-II" Alcoholic beverages served in relation to food service, with the food service constituting at least forty percent (40%) of the gross income of the establishment. Package sales of wine and champagne only shall be allowed. Gross annual dollar amount of liquor sales shall not exceed \$300,000.00."

SECTION 3: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language therein relative to the Class "N" liquor license to read in its entirety as follows:

"Class "N-I" - 1 Class "N-II" - 1"

SECTION 4: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by revising the language therein relative to the Class "N" liquor license to read in its entirety as follows:

"Class "N-I" - \$1,500.00 Class "N-II" - \$1,000.00 SECTION 5: That the current Class "N" liquor license issued to DOC West LLC, operating the business commonly known as DOC Wine Bar located at 326 Yorktown, Lombard, Illinois, is hereby changed to a Class "N-I" liquor license, as authorized in Section 3 above.

SECTION 6: That the current Class "N" liquor license issued to Pavmar Enterprises Inc., operating the business commonly known as Praga, located at 229 W. St. Charles Rd., Lombard, Illinois, is hereby changed to a Class "N-II" liquor license, as authorized in Section 3 above.

SECTION 7: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
