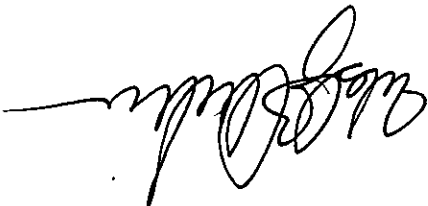

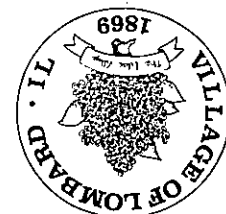

Subject: Update to Village Code on Refuse and Landscape Waste Disposal Fees

The new five-year agreement with Waste Management for trash removal services in the Village was approved by the Board of Trustees on May 4, 2006.

The enclosed changes to the Village ordinances were prepared by the Village Attorney and reflect the service prices established in the new agreement. Additionally the Attorney added language that will allow for the agreement's annual price adjustments without requiring a yearly update of this ordinance.

Please present this item to the Board of Trustees at their meeting on June 15, 2006. A waiver of first reading is requested to have the ordinance updated for the July 1st start of the new agreement.

**AN ORDINANCE AMENDING TITLE 9, CHAPTER 92, SECTION 92.17
OF THE LOMBARD VILLAGE CODE IN
REGARD TO REFUSE AND LANDSCAPE WASTE DISPOSAL FEES**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard,

DuPage County, Illinois, as follows:

SECTION 1: That Title 9, Chapter 92, Section 92.17(A)(1) of the Lombard Village

Code is amended as follows:

A. The reference therein to, "\$10.56," is amended to read, "\$12.42."

B. The last sentence thereof is amended to read in its entirety as follows:

"(\$12.07 Waste Disposal Firm charge (which includes \$1.00 for one Recyclables Cart), plus \$0.35 Village Service Fee)."
