

ORDINANCE NO. 4388

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:
