TITLE: Temporary Suspension of Commuter Parking Lot Fees

To help support essential workers and all active commuters, staff is proposing that all commuter parking fees be temporarily suspended through March 31, 2021. This is to assist commuters that have been affected by the COVID-19 pandemic, as well as to eliminate the need for commuters to touch the payboxes located at the Metra station. Parking fees were previously suspended through December 31, 2020.

Staff recommends the Village Board approve the attached ordinance to amend the Lombard Traffic Code (Ordinance No. 1186, as Amended) to continue to suspend commuter parking fees through March 31, 2021

**AN ORDINANCE AMENDING THE LOMBARD**  
**TRAFFIC CODE (ORDINANCE NO. 1186, AS AMENDED)**  
**IN REGARD TO COMMUTER PARKING FEES**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That, notwithstanding any provision of the Lombard Traffic Code (Ordinance No. 1186, as amended) that provides otherwise, in light of the COVID-19 pandemic, and its impact on mass transportation commuter travel, the payment of all commuter parking fees as provided for in the Lombard Traffic Code (Ordinance No. 1186, as amended) is hereby suspended through March 31, 2021.

**SECTION 2:** That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of the appropriate signs as provided by law.
