Subject: Tree Consortium Bid waiver

On August 4, 1988, the Village Board approved participation in the Suburban Tree Consortium. Representing 48 member communities, this organization handles the tree planting bid process in accordance with State of Illinois law. As a member, the Village must commit to a lead-time of five years for the purchase of trees grown based upon projected orders for trees.

\$98,000.00 is currently budgeted for parkway tree planting for FY21. This figure represents approximately 300 trees scheduled be planted in the Spring & Fall 2021 planting seasons, including replacement trees for the Lombard Meadows III project and 40 Community Development trees. As a formality, the Village Attorney has recommended waiving bids and approval of this payment.

The Suburban Tree Consortium provides top quality trees grown specifically for parkway conditions. West Central Municipal Conference acts as the Secretariat for the Suburban Tree Consortium. We have received a superior product in the past and recommend waiver of bids in an amount not to exceed \$98,000.00 for trees through the West Central Municipal Conference for FY21.
