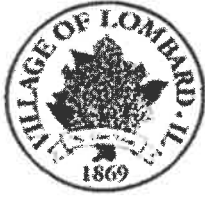

**SUBJECT:** **Amending Title XI, Chapter 112, Section 112.39(B)**  
**Live Entertainment Licensing Term Dates**

At the March 21, 2019 Village Board meeting, the Board of Trustees approved Ordinance 7641 amending Section 112.16 of the Lombard Village Code changing the two liquor licensing terms to January 1<sup>st</sup> through June 30<sup>th</sup> and July 1<sup>st</sup> through December 31<sup>st</sup>.

Village Code Section 112.39, Live Entertainment on Licensed Premises, allows a liquor licensee to apply for a live entertainment license for a six-month period to coincide with either/both of the two liquor licensing terms stated above for an additional fee of \$250.00.

The licensing term dates currently reflected in Section 112.39 are not consistent with the licensing term dates found in Section 112.16. Consequently, Village Counsel drafted the attached ordinance for Village Board consideration.

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.39(B)  
OF THE LOMBARD VILLAGE CODE IN REGARD TO LIQUOR LICENSEES  
AND LIVE ENTERTAINMENT ON THE LICENSED PREMISES**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title XI, Chapter 112, Section 112.39(B) of the Lombard Village Code is amended as follows:

- A. The reference to "May 31", as contained therein, is revised to read "June 30th".
- B. The reference to "November 30", as contained therein, is revised to read "December 31st".
- C. The reference to "June 1", as contained therein, is revised to read "July 1st".
- D. The reference to "December 1", as contained therein, is revised to read "January 1st".

**SECTION 2:** That all live entertainment licenses, issued pursuant to Title XI, Chapter 112, Section 112.39 of the Village Code, relative to liquor licenses issued for the July 1, 2019 through December 31, 2019 liquor licensing period, shall be valid through December 31, 2019.

**SECTION 3:** That this Ordinance shall be in full force and effect from and after its passage and approval, as provided by law.
