

ORDINANCE NO. 5101

AN ORDINANCE AMENDING ARTICLE XIII OF THE LOMBARD TRAFFIC CODE (ORDINANCE NO. 1186) IN RELATION TO COMMUTER PARKING LOTS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That the Lombard Traffic Code is hereby amended by revising the second sentence of Article XIII, Section 10-13-14(a) thereof to read in its entirety as follows:

"The payment of fees in the coin box shall be required between the hours of 5:00 a.m. and 5:00 p.m., except Saturdays, Sundays and holidays; provided, however, that for purposes of this Section the term holiday shall include only the following days: the first day of January, the fourth Monday of May, the fourth day of July, the first Monday in September, the fourth Thursday in November and the twenty-fifth day of December."

SECTION 2: That the Lombard Traffic Code is hereby amended by revising Article XIII, Section 10-13-22 to add a new subsection (e) which shall read in its entirety as follows:

"(e) Vehicles parked in those parking lots referenced in Schedule XIV shall be required to display a valid Village of Lombard Municipal Parking Permit between the hours of 5:00 a.m. and 5:00 p.m., except Saturdays, Sundays and holidays; provided, however, that for purposes of this Section the term holiday shall include only the following days: the first day of January, the fourth Monday of May, the fourth day of July, the first Monday in September, the fourth Thursday in November and the twenty-fifth day of December."

SECTION 3: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
