SUBJECT: Request for a Class "C" Liquor License
The Simple Greek – 789 E. Butterfield Rd.

The Village has received a request for a Class "C" liquor license (beer and wine) from The Simple Greek Chicagoland LLC d/b/a The Simple Greek located at 789 E. Butterfield Road. The restaurant will offer Greek cuisine in a fast-casual setting whereby patrons proceed to the service counter line where they can build their own bowls or pita sandwiches. The interior of the restaurant will have a combination of two-top and four-top tables, some counter seating, and additional seating outdoors for approximately 12-16 patrons.

Attached is an ordinance increasing the Class "C" liquor license category by one and issuing a liquor license to from The Simple Greek Chicagoland LLC d/b/a The Simple Greek.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor license, contained therein, to read as follows:

Class "C" - 6

This increase in Class "C" liquor licenses reflects the issuance of a Class "C" liquor license to The Simple Greek Chicagoland LLC who will be operating the business commonly known as The Simple Greek located at 789 E. Butterfield Road, Lombard.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
