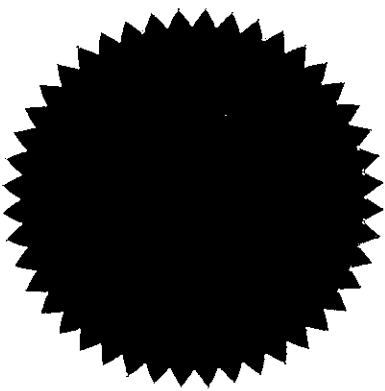

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule IV of the Lombard Traffic Code (Ordinance 1186) entitled STOP STREETS be amended to add the following thereto:

Name of Street	Shall Stop At	Name of Street
Liberty Lane	"	Adams Street

Section 2: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

Name of Street	From	To
Edgewood Avenue	North curb line of the southern leg of Washington Blvd.	South curb line of the northern leg of Washington Blvd.
Eisenhower Lane North	858 feet east of the east curb line of Eisenhower Lane	a point 910 feet east
Oakton Drive	140 feet north of the north curb line of Majestic Drive	a point 210 feet north and west

Section 3: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.


