Subject: Lift/Pump Station Improvements

Design Engineering Contract

Attached please find a resolution, contract, and fee schedule for design engineering services for improvements to ten lift/pump stations. The station improvements are individual projects as identified by the Underground Utilities Division that will help alleviate localized flooding that occurred during the July 2010 storm event. Stations to be addressed include:

Cambria

• Grace and Central

Vista Pond

- Charles Lane
- Kenilworth
- Finley Road

- Elizabeth/Morris
- Olde Towne
- Prairie/Lalonde

• Fairview

Also incorporated into the scope of work is an expanded wetland study/delineation of the northern portion of Charles Lane Pond. As part of the lift station improvements project, a wetlands delineation is being performed on a portion of Charles Lane Pond. The location of future on-site generators for two stations (Charles Lane and Finley Road) has the potential of being placed within the Charles Lane Pond wetlands. The Engineering Division wishes to expand the wetland study to include the northern portion of Charles Lane Pond. The expanded wetland study is needed to determine the feasibility of expanding Charles Lane Pond to increase the storm water capacity of the pond. The wetland study is the first step in determining what parameters DuPage County would place on the potential project.

The scope of the proposed work varies from station to station but may include raising or replacing the existing the control cabinets, installing on-site generators and replacing the existing pumps. The intent of the contract is for the Engineer to review, evaluate and possibly propose an alternative solution to the actions recommended by Village Staff. After reviewing information about each station and the reasons for localized flooding associated with each station, the Engineer will prepare a PDR (Project Development Report) that will specifically outline the extent of each proposed improvement. Upon concurrence of Village staff and the Board of Trustees, the Engineer will then proceed to prepare construction documents for each station.

This project was sent to the current Hydraulic and Hydrology Engineering Short-List. Four of the five firms responded to the Request for Proposal. Baxter & Woodman was determined to be the most qualified firm for this project. Baxter & Woodman is currently working on the Illinois Route 53 Storm Water Pump Station project.

The scope and fee were negotiated with Baxter & Woodman and agreed to by both parties. This work will be performed for a not-to-exceed phase 1 and 2 design engineering services fee of \$122,057.00.00. The engineering costs will be paid for using the Water and Sewer Capital Reserve Fund.

Please present this agreement and resolution to the President and Board of Trustees for their review at their regular meeting of March 3, 2011. If approved, please return one original signed copy to Public Works-Engineering for further processing.
