

ORDINANCE NO. 4941

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF LOMBARD, DUPAGE COUNTY, ILLINOIS (1200 S. Highland, Lombard, Illinois)

WHEREAS, the following described unincorporated territory is completely surrounded by the Village of Lombard; and

WHEREAS, the following described unincorporated territory is comprised of less than sixty (60) acres of land area; and

WHEREAS, the Village of Lombard desires to annex the following described unincorporated territory pursuant to 65 ILCS 5/7-1-13; and

WHEREAS, notice of said contemplated annexation was published in the Lombard Spectator newspaper on February 9, 2001, said newspaper being a newspaper of general circulation within the territory to be annexed; a copy of the Publisher's Certificate relative to said publication being attached hereto as Exhibit "A", and made part hereof, and

WHEREAS, written notice of said contemplated annexation was sent by certified mail, return receipt requested, to each Trustee of the York Center Fire Protection District, the York Township Highway Commissioner, each member of the Board of Trustees of York Township and each property owner within the territory to be annexed on February 9 2001; an Affidavit of Service relative to said notice being attached hereto as Exhibit "B", and made part hereof, and the return receipt cards being attached hereto as Exhibit "C", and made part hereof, and

WHEREAS, all necessary legal requirements are in full compliance with the terms of 65 ILCS 5/7-1-13; and

WHEREAS, it is in the best interests of the Village of Lombard that the following described unincorporated territory be annexed thereto;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That the following described territory:

LOT 1 IN ROOSEVELT HIGHLAND SHOPPING CENTER BEING A SUBDIVISION OF THAT PART OF THE WEST HALF (W.1/2) OF THE NORTHWEST QUARTER (NW.1/4) OF SECTION TWENTY (20), TOWNSHIP THIRTY NINE (39) NORTH, RANGE ELEVEN (11), EAST OF THE THIRD PRINCIPAL MERIDIAN, IN DUPAGE COUNTY, ILLINOIS

SECTION 3: That the Village Clerk is hereby directed to give written notice of this annexation, by certified mail return receipt requested, to the election authority having

within thirty (30) days of the date of this Ordinance.
