Section 1: That Schedule X of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS, Section (a), be amended to add the following hereto:

From

Hickory Road, Both Sides

Elizabeth Street

A point 1,200 feet east of Elizabeth Street

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
