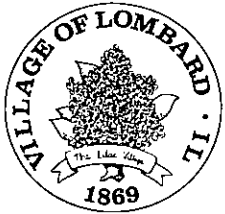

**ORDINANCE \_\_\_\_\_**  
**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,**  
**SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN**  
**REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II" liquor license, contained therein, to read as follows:

Class "A/B-II" - 8

This decrease in Class "A/B-II" liquor licenses reflects the termination of Sadco Inc. d/b/a Sal's Pizza and the termination of the Class "A/B-II" liquor license issued to Sadco Inc. in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II" liquor license, contained therein, to read as follows:

Class "A/B-II" - 9

This increase in Class "A/B-II" liquor licenses reflects the issuance of a Class "A/B-II" liquor license to Sadco One Inc. who is operating the business commonly known as Sal's Pizza located at 410 W. 22<sup>nd</sup> Street, Lombard.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
