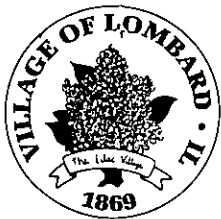

Included in the FY 2012 budget is the replacement for a Public Works Street Department tandem axle dump truck with plow and salt spreader (unit # ST329). State bid for this type of vehicle has been awarded to Prairie International Trucks (contract # 4015050) of Springfield (IL). The cost of the truck is \$153,395. Prairie International has offered an \$11,000 trade-in allowance for our old truck; this makes the total amount needed for this purchase \$142,395. The budgeted amount for this purchase is \$147,000.

I recommend the B.O.T. waive bid and award a contract to Prairie International of Springfield (IL) in the amount of \$142,395 for one new tandem axle dump truck with plow and salt spreader. I also recommend declaring Village unit # ST329 as surplus per the attached ordinance and authorizing its trade-in. Waiver of first reading is requested on this ordinance. Please submit this item to the Village Board for their consideration at the January 20, 2011 meeting.

**ORDINANCE AUTHORIZING THE SALE AND/OR DISPOSAL  
OF MUNICIPAL OWNED PERSONAL PROPERTY**

**WHEREAS**, in the opinion of the Corporate Authorities of the Village of Lombard, it is no longer necessary or useful to or in the best interest for the Village of Lombard to retain the following described personal property:
