RE: Ordinance Amending Title 9 Ambulance Fees

Effective January 1, 2006 a revision of the Ambulance Fee Schedule will take effect. As in the past we have recommended to revise our ambulance fees to reflect allowable increases as per the Centers for Medicare and Medicaid Services (CMS). Below are the current rates and proposed changes in the fee schedule.

**ORDINANCE AMENDING TITLE 9, CHAPTER 91,
SECTION 91.21 OF THE LOMBARD VILLAGE CODE
IN REGARD TO EMERGENCY MEDICAL SERVICES**

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Title 9, Chapter 91, Section 91.21 (A) & (B) of the Lombard Village Code is amended to read in its entirety, effective January 1, 2006, as follows:

§91.21 FEES

(A) Fees are hereby imposed upon residents and non-residents of the Village of Lombard using Emergency Medical Service provided by the Village of Lombard at the following rates:

	Village Resident	Glenbard Fire Protection District Resident	Non-Village/Non-Glenbard Fire Protection District Resident
Basic Life Support (BLS)-Transport	\$335.00	\$335.00	\$435.00
Advanced Life Support- Level I (ALS-I)-Transport	\$400.00	\$400.00	\$500.00
Advanced Life Support- Level II (ALS-II)-Transport	\$575.00	\$575.00	\$675.00
Advanced Life Support (ALS) Treatment, but no Transport	\$50.00	\$50.00	\$75.00

(B) In addition to the fees set forth in subsection (A) above, a mileage fee shall be charged in regard to Emergency Medical Transportation Service provided by the Village at the rate of \$6.05 per mile.

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form as provided by law.
