Number of Authorized Liquor Licenses - Class "A/B-II"

Casey's Restaurant & Bar – 415 E. North Avenue

Ulysses Restaurants Inc. d/b/a Casey's Restaurant & Bar located at 415 E. North Avenue currently holds a Class "A/B-II" liquor license which allows them to serve alcoholic beverages as an adjunct to food service with no packaged sales. Staff received a letter on September 7, 2017 from the restaurant owner requesting that their liquor license be cancelled effective September 5, 2017 as the restaurant is now closed for business.

In response to that request, attached is an ordinance decreasing the Class "A/B-II" liquor license category by one as required by Village Code.

Staff is requesting a waiver of first reading in order to bring the number of licenses available in the Class "A/B-II" liquor classification current to reflect this change.

## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

## BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II" liquor license category contained therein, to read as follows:

Class "A/B-II" - 9

Section 2: That the decrease in the number of Class "A/B-II" liquor licenses set forth in Section 1 above, is a result of Ulysses Restaurants Inc. d/b/a Casey's Restaurant & Bar located at 415 E. North Avenue no longer conducting business.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
