Staff are requesting a waiver of first reading.

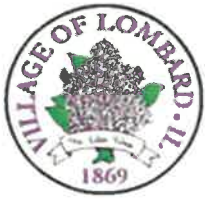

SUBJECT: **Amending Title XI, Chapter 112 – Authorizing One New Class “MM” Liquor License and Issuance to Dave & Buster’s of Lombard, LLC d/b/a Dave & Buster’s, 306 Yorktown Shopping Center**

The Village received a request for a Class “MM” liquor license from Dave & Buster’s of Lombard, LLC d/b/a Dave & Buster’s, located at 306 Yorktown Shopping Center, effective August 15, 2024, for the July 1 – December 31, 2024, license term.

Ordinance #8200 for a new sub-section for the Class “M” category and a newly created Class “MM” was on Consent Agenda and passed by the Board of Trustees on November 2, 2023.

The new Class “MM” Subcategory includes the following:

- Gross revenue from food and beverage sales exceeds \$1,000,000.00 on an annual basis with at least \$350,000.00 in gross sales of alcoholic liquor.
- Operation of eight or more coin-operated amusement devices
- Packaged liquor sales are prohibited.
- Video gaming shall not be allowed.
- The semi-annual fee is \$2,000

“(F) At least 30 days prior to any liquor license renewal date, Class MM Liquor License holders shall file with the Local Liquor Control Commissioner a statement under oath, accompanied by written documentation, as to the dollar amount of all food and beverage sales for the previous 12 months and the dollar amount of liquor sales for the previous 12 month period, to allow a determination to be made as to whether gross food and beverage sales exceeded \$1,000,000.00 and gross liquor sales exceeded \$350,000.00.”

Dave & Busters is an entertainment and a family-oriented restaurant establishment, offering a variety of games, food, and beverage options. The brand operates over 140 locations nationwide including four (4) locations within Illinois in addition to a newly opened establishment within the Village of Schaumburg at the Streets of Woodfield, February 2024.

The attached ordinance reflects the authorization and issuance.

ORDINANCE NO. _____

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES AUTHORIZING ONE NEW CLASS “MM” AND ISSUANCE IN RELATION THERETO

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code relative to the Class “MM” liquor license is amended by increasing the number of available licenses from zero (0) to one (1), so that the provision therein relative to the Class “MM” liquor license reads in its entirety as follows:

“Class “MM” – 1”

The creation of one new Class “MM” liquor license reflects the issuance of a Class “MM” liquor license to Dave & Busters of Lombard, LLC. d/b/a Dave & Buster’s, located at 306 Yorktown Shopping Center, Lombard, Illinois.

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
