SUBJECT: **Places for Eating (PFE) and Amusement Taxes - Collection Commission
Title IX, Chapter 98, Sections 98.111(D)(3) and 98.114(D)(3)**

BACKGROUND

The Village of Lombard levies a 2% Places for Eating (PFE) Tax on the gross receipts of any premises located within the corporate limits of the Village of Lombard where prepared food is sold at retail for immediate consumption, with seating provided for consumption of prepared food on the premises, whether consumed on premises or not. The Village also levies a 5% Amusement Tax on the gross receipts of any premises that has "amusement" as defined under Section 98.114 of Village Code.

Places for Eating and Amusement taxes must be paid to the Village by the 20th day of the month following the businesses' reporting period (normally every month) unless their State of Illinois sales tax returns are filed on a quarterly or annual basis.

PRIOR AMENDMENTS TO VILLAGE CODE

Staff has been refining Village Code to reflect current procedures and circumstances required to maintaining the PFE and Amusement Tax programs. To date the following amendments have been requested by staff and approved by the Village Board:

- **Ordinance 7514** – approved on May 3, 2018
Added language to Village Code to clarify that penalties and interest applied to a late filing and late tax payment relative to the PFE program
- **Ordinance 7516** – approved on May 3, 2018
Added language to Village Code to clarify that penalties and interest applied to a late filing and late tax payment relative to the Amusement Tax program
- **Ordinance 7595** – approved November 1, 2018
Repealed a subsection of Village Code which deleted the late payment interest provision

CURRENT REQUEST TO AMEND VILLAGE CODE

Currently, any entity who is required to pay either the PFE and/or the Amusement tax and pays their tax on time, may keep a commission of one percent (1%) of the amount of the tax, to reimburse for expenses incurred in the administration of the tax. Village Code requires that a tax filing form as well as a tax payment be made to satisfy the remittance requirements of both programs but is silent about the applicability of the 1% collection commission should an entity submit their tax payment on time but not file the tax form on time or vice versa.

In order to clarify Village Code, Village staff has conferred with Village Counsel who has drafted the attached ordinance. This ordinance specifies that in order for an entity to keep the 1% collection commission, they must pay the tax on time **and** file the tax return form on time. If one or the other is not filed on time, then the entity is not entitled to keep the 1% collection commission.

Please place this item for consideration on the December 6, 2018 Village Board agenda. Village staff recommends approval of this request.
