AN ORDINANCE AMENDING TITLE 3, CHAPTER 33 OF THE LOMBARD VILLAGE CODE IN REGARD TO THE ELIMINATION OF THE DEPUTY FIRE CHIEF POSITION, CREATION OF ASSISTANT FIRE CHIEF POSITION, AND RESIDENTIAL DWELLING PROXIMITY REQUIREMENT FOR CERTAIN FIRE DEPARTMENT POSITIONS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 3, Chapter 33, § 33.02(A) of the Lombard Village Code is amended by eliminating the office and rank of Deputy Chief listed in § 33.02(A)(1), and shall hereafter read as follows:

§ 33.02 OFFICES AND RANKS CREATED – NUMBER – SPECIAL REQUIREMENTS

- (A) The various offices and ranks listed below are hereby created:
 - (1) Battalion Chief
 - (2) Lieutenant
 - (3) Firefighter

The number authorized to serve in each rank shall be as determined annually in the Budget Ordinance adopted by the Village.

SECTION 2: That Title 3, Chapter 33 of the Lombard Village Code is amended by renumbering current § 33.22, entitled "PRESENT OFFICERS CONTINUE IN OFFICE," as § 33.23, and inserting a new § 33.22 to read as follows:

§ 33.22 ASSISTANT FIRE CHIEF; POWERS AND DUTIES

(A) The Village Manager is authorized to appoint and remove an Assistant Fire Chief, who shall be a non-sworn, administrative officer of the Fire Department.

(B) The Assistant Fire Chief shall perform the duties, and exercise the powers, as directed by the Village Manager and the Fire Chief.

SECTION 3: That Title 3, Chapter 33 of the Village Code is amended by adding § 33.24, to read as follows:

§ 33.24 RESIDENTIAL DWELLING PROXIMITY REQUIREMENT

- (A) The following members of the Fire Department shall be required to reside within a five (5) mile radius of the intersection of Main Street and Wilson Avenue in the Village:
 - (1) Fire Chief
 - (2) Assistant Fire Chief
 - (3) Battalion Chief
- (B) Any person promoted or appointed to a position covered by this Section who does not meet the requirement of this Section at the time of promotion or appointment, shall have one (1) year to come into compliance with this Section from the date of promotion or appointment. The Village Manager shall have the discretion to grant said persons additional time to come into compliance with this Section based on a showing of hardship.

SECTION 4: That this Ordinance shall be in full force and effect from and after its adoption, approval and publication in pamphlet form as provided by law.
