ORDINANCE NO. 7132

AN ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule XII (a) Permit Parking Zones of the Lombard Traffic Code is amended as follows:

(a) "Vehicles parked in those parking lots referenced in Schedule XII (a) shall be required to display a valid Village of Lombard Municipal Parking Permit between the hours of 5:00 a.m. and 11:00 a.m."

Section 2: That Schedule XII (c) Lombard Resident Permit Parking Zones of the Lombard Traffic Code is amended as follows:

(c) "Vehicles parked in those parking lots references in Schedule XII (c) shall be required to display a valid Village of Lombard Municipal Resident Parking Permit between the hours of 5:00 a.m. and 11:00 a.m."

Section 3: That Schedule XII (d) Lombard Resident Daily Fee Parking Zones of the Lombard Traffic Code is amended as follows:

(d) "The payment of fees in the coin box shall be required between the hours of 5:00 a.m. and 11:00 a.m."

Section 4: That Section 10-13-14 (a) Parksafe Fees and Time Limits; Use of Proceeds of the Lombard Traffic Code is amended as follows:

(a) "The payment of fees in the coin box shall be required between the hours of 5:00 a.m. and 11:00 a.m., except Saturdays, Sundays, and holidays..."

Section 5: That Section 10-13-22 Municipal Parking Permits of the Lombard Traffic Code is amended as follows:

- (e) "Vehicles parked in those parking lots referenced in Schedule XII (a) shall be required to display a valid Village of Lombard Municipal Parking Permit between the hours of 5:00 a.m. and 11:00 a.m."
- (f) "Vehicles parked in those parking lots referenced in Schedule XII (c) shall be required to display a valid Village of Lombard Municipal Parking Permit between the hours of 5:00 a.m. and 11:00 a.m."

<u>Section 6:</u> That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
