SUBJECT: Ordinance Amending Section 152.28 (A) of the Lombard Village Code

The Village regulates the naming of public roadways in Lombard. The Village Code contains language that allows the Village Board to place honorary street names upon Village roadways, subject to a request and a review by staff. The Current language in the Code provides that the honorary street name designation shall only be in effect for a period of one year. Additionally, the process requires that the Community Development Director oversee the process. Staff has reviewed the Code and determined that the one-year time frame is not necessary and the all requests should be made through the Director of Public Works.

I respectfully request that this matter be placed on the Village Board agenda for the February 20, 2020 meeting for consideration.

Recommendation

Staff recommends that the Village President and Board of Trustees approve the Ordinance Amending Section 152.28 (A) of the Lombard Village Code.

**AN ORDINANCE AMENDING TITLE 15, CHAPTER 152, SECTION 152.28
OF THE LOMBARD CODE IN REGARD TO THE HONORARY
NAMING OF PUBLIC STREETS**

WHEREAS, the Village of Lombard has established and maintains regulations on the honorary naming of public streets, which are found in Title 15, Chapter 152, Section 152.28 of the Lombard Village Code; and,

WHEREAS, the Village finds that Section 152.28 (A) of the Lombard Village Code should be amended to address the length of time a public street can receive an honorary street name; and,

WHEREAS, the Board of Trustees deem it reasonable to periodically review the Lombard Village Code to ensure that the regulations adequately meet the health, safety and welfare needs of the Village, and make necessary changes when warranted;

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That Title 15, Chapter 152, Section 152.28 (A) is hereby amended in its entirety as follows:

“(A) The Village Board may, by Ordinance, authorize the naming of a driveway on public property or a dedicated alley with an honorary street name. A requestor shall make application for such designation to the Public Works Director. The Public Works Director shall seek comments from the Police Chief and Fire Chief, and shall forward a recommendation to the Village Board. If approved by the Village Board, the Public Works Department shall erect the street signs. The requestor shall pay for the cost of the sign and installation unless such costs are waived by the Village Board. The Public Works Director shall notify any agencies that might be impacted by the honorary street naming.”

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
