SUBJECT: 2023 Asphalt Resurfacing Contract - Rejection of Bids

The Village solicited bids for the 2023 Asphalt Resurfacing Contract. The project was bid using the MPI process, which aggregates quantities from municipal units of government. The procurement process included the Village of Lombard, Village of Woodridge and the Glenbard Wastewater Authority. Bids were opened on April 21, 2023 and the Village received two (2) bids. Based upon the evaluation of the bids, the Village staff recommends that the Village board reject all bids and authorize staff to negotiate with the two bidders for the contract.

A contract for the 2023 Asphalt Resurfacing Contract will be presented to the Village Board at a future meeting for consideration. The Village would be waiving the competitive bids and awarding a contract based upon these negotiations in accordance with Section 35.26 of the Village Code, which states, "*The Board of Trustees, by a two-thirds vote of all the Trustees then holding office, may waive the foregoing bidding procedures and enter into a contract or agreement*".
