SUBJECT: **Adidas Tent Sale at Yorktown Mall Special Event**

Big Top Tents, LLC has submitted an application for a Temporary Special Event Permit for an Adidas Tent Sale to be located at 203 Yorktown Shopping Center in the parking lot along Highland Avenue. The event is proposed for five (5) days from May 26 thru May 30, 2016. According to Section 110.47 (D) of the Lombard Code of Ordinances, Temporary Special Event permits are valid only for three (3) days. An extension is therefore requested from the Village Board for this permit.

Staff recommends that the Village Board grant an extension for the temporary event to run more than three days.

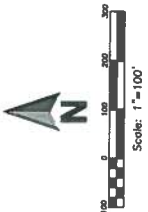
