BACKGROUND/POLICY IMPLICATIONS:

Attached is an ordinance amending Title 11, Chapter 112, Section 112.13(A) (effective June 1, 2017) relative to liquor license classification changes for Topaz RG LLC d/b/a Babcock's Grove House located at 101 W. St. Charles Road and Platinum Bar and Grill Inc. d/b/a Overtime Bar and Grill, located 801 E. Roosevelt Road due to an increase in their 2016 annual gross dollars of alcoholic liquor sales.

SUBJECT: **Liquor License Classification Changes**

Please be advised liquor license holders with a Class "A/B" license are required to report their annual gross dollars of alcoholic liquor sales yearly. Two (2) of our liquor license holders require a change in their classification effective with the June 1 through the November 30, 2017 licensing term:

Topaz RG LLC d/b/a Babcock's Grove House, located at 101 W. St. Charles Road, reported an increase in their 2016 sales which changes their classification from a Class "A/B-I" to a Class "A/B II"; and

Platinum Bar and Grill Inc. d/b/a Overtime Bar and Grill, located at 801 E. Roosevelt Road, reported an increase in their 2016 sales which changes their classification from a Class "A/B-II" to a Class "A/B-III".

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF
THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That, effective June 1, 2017, Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-I" liquor licenses, contained therein, to read as follows:

"Class "A/B-I" – 8"

SECTION 2: That, effective June 1, 2017, Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B II" liquor licenses, contained therein, to read as follows:

"Class "A/B-II" – 10

SECTION 3: That, effective June 1, 2017, Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor licenses, contained therein, to read as follows:

"Class "A/B- III" – 13"

SECTION 4: That the changes in the number of Class "A/B-I", "A/B-II" and "A/B-III" liquor licenses set forth in Sections 1, 2 and 3 above are as a result of Topaz RG LLC d/b/a Babcock's Grove House, located at 101 W. St. Charles Road, reporting an increase in their gross dollars of liquor sales in calendar year 2016, resulting in a change from a Class "A/B- I" liquor licensee to a Class "A/B-II" liquor licensee and Platinum Bar and Grill Inc. d/b/a Overtime Bar and Grill, located at 801 E. Roosevelt Road, reporting an increase in their gross dollars of liquor sales in calendar year 2016, resulting in a change from a Class "A/B-II" liquor licensee to a Class "A/B-III" liquor licensee.

SECTION 4: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
