**SUBJECT: Liquor License - Bricks Wood Fired Pizza & Cafe**

Brix Woodfired Pizza Inc. d/b/a Bricks Woodfired Pizza & Café, located at 132 W. St. Charles Road, currently holds a Class "C" liquor license which allows them to serve beer and wine. Staff was notified that they have changed their corporation name from "**Brix**" to "**Bricks**" Wood Fired Pizza Inc. d/b/a Bricks Wood Fired Pizza & Café. Village Code requires that a liquor license shall terminate whenever there is a corporation change even if there has not been an ownership change.

Attached is an ordinance decreasing and increasing the number of Class "C" liquor licenses by one, to reflect the new corporation name as well as to correct the word "Woodfired" which should be two words "Wood Fired".

Staff is requesting a waiver of first reading in order to reflect the new corporate name change.

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,  
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the "Class "C" liquor license, contained therein, to read as follows:

Class "C" - 6

This decrease in Class "C" liquor license reflects the corporate name change of Bricks Woodfired Pizza & Cafe, located at 132 W. St. Charles Road, and the termination of the Class "C" liquor license issued to Brix Woodfired Pizza Inc. in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor license, contained therein, to read as follows:

Class "C" - 7

This increase in Class "C" liquor licenses reflects the issuance of a Class "C" liquor license to Bricks Wood Fired Pizza Inc., who is operating the business commonly known as Bricks Wood Fired Pizza & Café located at 132 W. St. Charles Road, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
