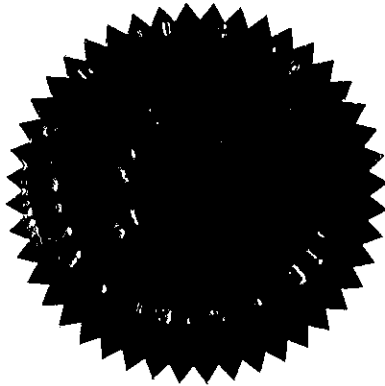

**ORDINANCE NO. 4867**

**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VIII (o) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS between the hours of 8:00a.m. – 4:00p.m. on school days be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Green Valley Drive East side	North curb line of Madison Street	a point 150 feet north
Hammerschmidt Ave. East side	225 feet north of the north curb line of Harding Road	a point 110 feet north

Section 2: That Schedule VIII (p) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS between the hours of 8:00a.m. – 9:00a.m. on school days be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Hammerschmidt Ave. East side	40 feet north of the north curb line of Harding Road	a point 185 feet north

Section 3: That Schedule XIV (f) of the Lombard Traffic Code (Ordinance 1186) entitled NO LEFT TURN between the hours of 8:00a.m. – 4:30p.m. on school days be amended to delete the following therefrom:

<u>Name of Street</u>	<u>Direction</u>	<u>At</u>
Madison School Driveway	Southbound	West Green Valley Drive

Section 4: That Schedule XX (b) of the Lombard Traffic Code (Ordinance 1186) entitled NO STOPPING, STANDING OR PARKING between the hours of 8:00a.m. – 4:00p.m. on school days be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Hammerschmidt Ave. East side	290 feet north of the north curb line of New Street	a point 370 feet north

Section 5: That Schedule V of the Lombard Traffic Code (Ordinance 1186) entitled PREFERENTIAL STREETS be amended to delete the following therefrom:

Grove Street will yield to Charlotte Street  
 Hammerschmidt Avenue will yield to Taylor Road  
 Hammerschmidt Avenue will yield to Harrison Road  
 Central Avenue, eastbound will yield to Charlotte  
 Elizabeth Street will yield to Sunset Street  
 Sunset Street will yield to Elizabeth Street  
 Charlotte Street will yield to Taylor Road

Section 6: That Schedule IV of the Lombard Traffic Code (Ordinance 1186) entitled STOP STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>Shall Stop At</u>	<u>Name of Street</u>
Charlotte Street	“	Taylor Road
LaLonde Avenue	“	17 <sup>th</sup> Street

Section 7: That Schedule XX (b) of the Lombard Traffic Code (Ordinance 1186) entitled NO STOPPING, STANDING OR PARKING between the hours of 8:00a.m. – 4:00p.m. on school days be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
West Green Valley Drive East side	North curb line of Madison Street	a point 125 feet north
Hammerschmidt Ave. East side	245 feet north of the north curb line of New Street	a point 495 feet north

Section 8: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Highridge Avenue North & south sides	East curb line of Westmore/Meyers Road east	Village limits

Section 9: That Schedule X (d) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS for a period not to exceed 2 hours between the hours of 8:00a.m. – 6:00p.m. on any day except Sundays and holidays shall be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Willow Street, North side	160 feet west of the west curb line of Main Street	a point 210 feet west
Willow Street, South side	75 feet west of the west curb line of Main Street	a point 160 feet west

Section 10: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
