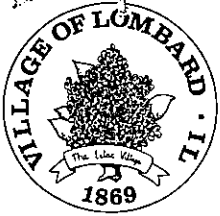

Subject: Recommendations from the Transportation and Safety Committee

At the December 5, 2005, Transportation and Safety Committee meeting, the committee recommended the following items:

- 050691 – Revise the West Road “No Parking” zones, north of the intersection with St. Charles Rd. This will eliminate the “No Parking” zone on the east side and reduce the “No Parking” zone on the west side from 150 feet to 110 feet.
- 050693 – Post “No Truck Traffic Over 60,000 Pounds, Except Local Deliveries” along Technology Drive at Butterfield Road and the far east end.

The following sections of the traffic code require an ordinance:

Schedule VII – Parking Prohibited at all Times on Certain Streets

Remove:

West Road, east side	North curb line	A point 95
	of St. Charles Rd.	feet north

Revise:

West Road, west side	North curb line	A point 110
	of St. Charles Rd.	feet north

Add New Schedule:

Schedule XIX (b) – No Truck Traffic Over 60,000 Pounds, Except Local Deliveries

Add: Technology Drive, from Butterfield Rd. to far east end.

ORDINANCE NO. _____

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
West Road, east side	North curb line of St. Charles Road	A point 95 feet north
West Road west side	North curb line of St. Charles Road	A point 150 feet north

Section 2: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
West Road, west side	North curb line of St. Charles Road	A point 110 feet north

Section 3: That Schedule XIX of the Lombard Traffic Code (Ordinance 1186) entitled VEHICLE WEIGHT RESTRICTIONS be amended to add the following thereto:

(b) In accordance with Village of Lombard Ordinances, no truck traffic over 60,000 pounds, except local deliveries is hereby established as described upon the following streets or parts of streets:

Technology Drive, from Butterfield Road to far east end

Section 4: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
