SUBJECT: BOT 14-02; Repeal of Approvals of an Annexation Agreement, Annexation, and Map Amendment (Rezoning) – 1200 & 1204 High Ridge Road

At the January 8, 2015 Board of Trustees meeting the properties at 1200 and 1204 High Ridge Road were annexed into the Village of Lombard and rezoned to R-1. Per the annexation agreement, the property owner was to extend utilities to the properties along High Ridge Road.

The property owner has expressed their desire to not proceed with the project, as stated in the attached letter. Also, per the annexation agreement, the property owner has reimbursed the Village for attorney fees.

AN ORDINANCE REPEALING IN THEIR ENTIRETY ORDINANCES 7038, 7039 AND 7040, WHICH ANNEXED THE PROPERTIES AT 1200 AND 1204 HIGH RIDGE ROAD, LOMBARD, ILLINOIS

BOT 14-02: 1200 and 1204 High Ridge Road

WHEREAS, on January 8, 2015, the President and Board of Trustees adopted Ordinances 7038, 7039 and 7040 approving an annexation and zoning relief for the properties commonly known as 1200 and 1204 High Ridge Road (collectively the "Property"), legally described as follows:

LOT 14 AND THE WEST ½ OF LOT 15 IN YORK TOWNSHIP SUPERVISOR'S ASSESSMENT PLAT NO. 2, ALSO KNOWN AS WESTMORE LANDS PART OF THE SOUTH ½ OF SECTION 16, TOWNSHIP 39 NORTH, RANGE 11, EAST OF THE THIRD PRINCIPAL MERIDIAN ACCORDING TO THE PLAT THEREOF RECORDED AUGUST 23, 1943 AS DOCUMENT NO. 453576, IN DUPAGE COUNTY, ILLINOIS

Parcel Identification Number(s): 06-16-400-001 and -002

WHEREAS, Ordinances 7038, 7039 and 7040 required the property owners to extend utilities to the Property; and

WHEREAS, the property owners have expressed a desire to not proceed with the utility extension project to the Property;

WHEREAS, the President and Board of Trustees find that the Property would be in violation of the Annexation Agreement without the utility extension; and

WHEREAS, it is in the best interest of the Village of Lombard that Ordinances 7038, 7039 and 7040 are repealed.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That Ordinances 7038, 7039 and 7040 are hereby repealed in their entirety, and is null and void.

<u>SECTION 2:</u> The repealed Ordinances shall no longer be in full force and effect from and after this passage and approval as provided by law.
