Attached are two originals of "The First Amendment to the Intergovernmental Agreement Between the County of DuPage and the Village of Lombard for the Construction of a Bicycle-Pedestrian Bridge to Grade Separate CH55 / Great Western Trail from Grace Street, UPRR and St Charles Road" and a Resolution authorizing the signature of the Village President and Village Clerk on the amendment.

The original agreement dated September 13, 2005, is for a grant from the County to the Village to assist with the Village's costs for engineering on the Great Western Trails Bridges project. The agreement calls for the County to pay to the Village certain sums based on the following schedule: \$50,000 for Phase I Engineering, \$50,000 for Phase II Engineering, and \$100,000 upon award of a construction contract for Phase III Engineering. The IGA was set to expire on December 31, 2010. The Amendment will extend the IGA to December 31, 2014.

Please present the Resolution and the First Amendment to the IGA document to the Village Board at their regularly scheduled meeting on November 18, 2010. If approved, please return the two executed originals to Public Works. We will then forward the originals to the County for their execution. After County approval, one original will be returned to the Village.

(COUNTY COST NOT TO EXCEED \$200,000)

THIS FIRST AMENDMENT TO THE INTERGOVERNMENTAL AGREEMENT BETWEEN THE COUNTY OF DU PAGE AND THE VILLAGE OF LOMBARD FOR THE CONSTRUCTION OF A BICYCLE-PEDESTRIAN BRIDGE TO GRADE SEPARATE CH 55/GREAT WESTERN TRAIL FROM GRACE STREET, UPRR AND ST. CHARLES ROAD, SECTION 05-00275-00-BT, dated September 13, 2005 (hereinafter referred to as the "FIRST AMENDMENT"), is entered into this _____ day of ______, 201___, between the County of DuPage (hereinafter referred to as the "COUNTY"), a body corporate and politic, with offices at 421 N. County Farm Road, Wheaton, Illinois, and the Village of Lombard (hereinafter referred to as "VILLAGE"), a municipal corporation with offices at 255 E. Wilson, Lombard, Illinois. The COUNTY and the VILLAGE are sometimes hereinafter individually referred to as a "party" or together as the "parties."

RECITALS

WHEREAS, the COUNTY and the VILLAGE entered into an Intergovernmental Agreement Between the County of DuPage and the Village of Lombard for the Construction of a Bicycle-Pedestrian Bridge to Grade Separate CH 55/Great Western Trail from Grace Street, UPRR and St. Charles Road, Section 05-00275-00-BT, dated September 13, 2005, (hereinafter referred to as the "AGREEMENT); and

WHEREAS, the parties previously agreed that the AGREEMENT would be in effect through December 31, 2010; and

WHEREAS, the VILLAGE has encountered delays and has requested that the parties extend the term of the AGREEMENT; and

WHEREAS, the COUNTY is willing to extend the term of the AGREEMENT.

NOW, THEREFORE, in consideration of the premises and mutual covenants contained herein, the parties agree that:

1.0 RECITALS INCORPORATED

1.1. The foregoing recitals are incorporated herein by reference as though fully set forth.

2.0 AMENDMENT

- 2.1. That the term of the AGREEMENT shall be amended to extend through December 31, 2014.
- 2.2. It is mutually agreed by and between the parties hereto that all covenants contained in the AGREEMENT which are not in conflict with this FIRST AMENDMENT shall remain in full force and effect and are incorporated herein and account of the conflict o
