**SUBJECT:** **Text Amendments to Village Code – Lucky Strike Lanes – 100 Yorktown**  
**Title 11, Chapter 112, Section 112.13(A) – Alcoholic Beverages**  
**Title 11, Chapter 110, Section 110.08(E) – Billiards; Bowling alleys**

At the close of business on December 30, 2015 Lucky Strike Lanes ceased operations. In that regard the above sections of Village Code are being amended:

- Lucky Strike Yorktown LLC d/b/a Lucky Strike Lanes located at 100 Yorktown currently holds a Class “R” liquor license which allows for alcoholic beverages served for consumption on the premises of a bowling alley. Attached is an ordinance decreasing the number of liquor licenses in the Class “R” liquor license category by one as required by Village Code.
- Lucky Strike Lanes also held a billiard/pool hall license. Attached is an ordinance decreasing the number of billiard/pool hall licenses by one.

On January 4, 2016 Lucky Strike Lanes surrendered their Class “R” liquor license and pool hall license (among others) to Village staff. Staff is requesting a waiver of first reading in order to bring the number of licenses current to reflect these changes.

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,  
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "R" liquor licenses contained therein, to read as follows:

Class "R" - 0

Section 2: That the decrease in the number of Class "R" liquor licenses set forth in Section 1 above, is a result of Lucky Strike Yorktown LLC d/b/a Lucky Strike Lanes no longer conducting business at 100 Yorktown.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 110,  
SECTION 110.08(E) OF THE LOMBARD VILLAGE CODE IN  
REGARD TO BILLIARDS; BOWLING ALLEYS**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 110, Section 110.08(E) of the Lombard Village Code is amended to read as follows:

(E) There shall be not more than ~~two (2)~~ one (1) billiard/pool hall license issued in the Village of Lombard.

Section 2: That the decrease in the number of billiard/pool hall licenses set forth in Section 1 above, is a result of Lucky Strike Yorktown LLC d/b/a Lucky Strike Lanes no longer conducting business at 100 Yorktown.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
