SUBJECT: **Text Amendment to Title 11, Chapter 112, Section 112.13(A)
Number of Authorized Liquor Licenses – Class “A/B-II-VG”
Ramey’s Bar and Grill – 2370 Fountain Sq. Drive**

Ramey’s Bar and Grill LLC d/b/a Ramey’s Bar and Grill located at 2370 Fountain Square Drive, currently holds a Class “A/B-II-VG” liquor license which allows them to serve alcoholic beverages as an adjunct to food service with no packaged sales as well as the ability to have video gaming. Staff received an email on January 22, 2020 from the restaurant owner advising that they have ceased doing business and the restaurant has been closed.

Attached is an ordinance decreasing the number of entries in the Class “A/B-II-VG” liquor license category by one as required by Village Code.

Staff is requesting a waiver of first reading in order to bring the number of licenses available in the Class “A/B-II-VG” liquor classification current to reflect this change.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF
THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II-VG" liquor license category contained therein, to read as follows:

Class "A/B-II-VG" - 2

Section 2: That the decrease in the number of Class "A/B-II-VG" liquor licenses set forth in Section 1 above, is a result of Ramey's Bar and Grill LLC d/b/a Ramey's Bar and Grill located at 2370 Fountain Square Drive no longer conducting business.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
