The Village of Lombard opened bids for the Parkway Tree Trimming contract on October 12, 2012. The lowest responsible bidder was received from Nels J. Johnson Tree Experts. The original contract was from January 1, 2013 to December 31, 2013 with an option to extend the contract from January 1, 2014 through December 31, 2014.

We have contacted Nels J. Johnson Tree Experts, and they have agreed to maintain their prices from the 2013 contract for the 2014 calendar year. Nels J. Johnson Tree Experts has provided good service to the Village. The FY14 budget contains \$65,000.00 for this service.
