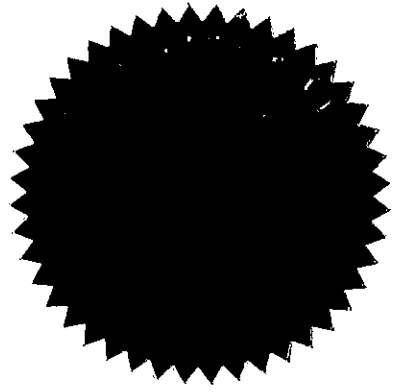

ORDINANCE AMENDING TITLE 3, CHAPTERS 33 AND 34
IN REGARD TO THE RULES AND REGULATIONS OF THE LOMBARD
FIRE AND POLICE DEPARTMENTS

ORDINANCE 5335

AN ORDINANCE AMENDING TITLE 3, CHAPTERS 33 AND 34 OF THE LOMBARD VILLAGE CODE IN REGARD TO THE RULES AND REGULATIONS OF THE LOMBARD FIRE AND POLICE DEPARTMENTS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard,

DuPage County, Illinois, as follows:

SECTION 1: That Title 3, Chapter 33, Section 33.04 of the Lombard Village Code is hereby

amended to read in its entirety as follows:

“§33.04 REPORT IN REGARD TO DEPARTMENT RULES AND REGULATIONS

The Fire Chief shall provide a copy of the current orders, rules and regulations of Fire Department, as promulgated by the Fire Chief pursuant to the authority granted by Section 33.21 of this Code, to each member of the Board of Trustees and each member of the Board of Fire and Police Commissioners, and shall provide any revisions to said orders, rules and regulations to said individuals at least once every three (3) months thereafter.”

SECTION 2: That Title 3, Chapter 34, Section 34.05 of the Lombard Village Code is hereby

amended to read in its entirety as follows:

“§ 34.05 REPORT IN REGARD TO DEPARTMENT RULES AND REGULATIONS

The Police Chief shall provide a copy of the current orders, rules and regulations of Police Department, as promulgated by the Police Chief pursuant to the authority granted by Section 34.21 of this Code, to each member of the Board of Trustees and each member of the Board of Fire and Police Commissioners, and shall provide any revisions to said orders, rules and regulations to said individuals at least once every three (3) months thereafter.”

SECTION 3: This ordinance No. 2575, adopted February 10, 1982, relative to the rules and regulations of the Lombard Police Department is hereby repealed.

SECTION 4: This ordinance No. 2598, adopted May 12, 1983, relative to the rules and regulations of the Lombard Fire Department is hereby repealed.






