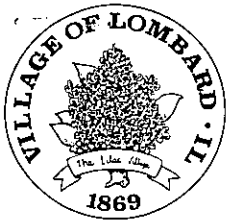

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.40(A)
OF THE LOMBARD VILLAGE CODE IN REGARD TO THE BASSET TRAINING PROGRAM**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.40(A) of the Lombard Village Code is amended by revising the reference therein to "all Class A/B-I, A/B-II, A/B-III, C, D, E-I, E-II, I, K, L, M, O, R, T, X and Z liquor license holders," to read, "all Class A/B-I, A/B-II, A/B-III, C, D, E-1, E-II, I, K, L, M, O, R, T, U, X and Z liquor license holders."

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
