3.0 Approval of Minutes

On a motion by Draus and seconded by Bedard, the minutes from the November 9, 2009 meeting were unanimously approved by the members present.

4.0 Unfinished Business

090705 Social Services Program

Request to review and discuss the Social Services Program.

Trustee Laura Fitzpatrick asked staff to go over the report and the recommendation to the Board. Staff reviewed the memo of November 2, 2009 and went over the staff recommendation of a partnership with the Tri-Town YMCA to provide some social services program to the Tri-Town communities. Trustee Fitzpatrick added that other options include to do nothing, recommend an outside contractor (similar to Elmhurst) or join the consortium that exists in Addison. Andy Draus offered that to hire a private contractor would probably be cost prohibitive. It was also discussed that funding for either the private contractor or the consortium would be approximately \$20,000, per Trustee Fitzpatrick. Kim Angland offered that the Tri-Town Y made it past the first round of cuts for the United Way grant for the program and was now in the second round of application. Andy Draus suggested that this item be tabled until we investigate and get more information from the Y regarding the funding, how much, renewable and to what extend a program would be funded.

It was moved by Angland, seconded by Wellwood-Burke, that this matter be continued to the February 8, 2010 meeting. The motion carried by a voice vote

Staff will contact Joanne Mitrenga, Executive Director of the Tri-Town YMCA to discuss the process and the status of the grant.

The committee also presented additions to be added to the Social Services Resource Guide. Staff will revise the guide and include any information that is excluded from the materials presented. It was also suggested to put the guide at the library and do to a press release on its availability. Eventually, it will also be online.
