Subject: Parkway and Landscape Restoration Contract Renewal

On October 23, 2020, the Village of Lombard opened bids for the Village contract **PWO 21-17B**, *Parkway*, *Turf*, *and Landscape Restoration*. The lowest responsible bid was received from Uno Mas Landscaping. The original contract was from March 1, 2021 through December 31, 2021, with two optional one-year extensions.

We have contacted Uno Mas Landscaping and they have agreed to the first of two one-year extensions at the prices submitted with their 2020 bid for the 2022 calendar year. Uno Mas Landscaping has provided good service to the Village and responded in a timely manner when there have been areas of concern. The FY22 budget contains \$50,000.00 from RM Prog 19 for parkway and landscape restoration.

Staff recommends renewing the Parkway and Landscape Restoration contract with Uno Mas Landscaping for the amount not to exceed \$50,000.00. Please present this item to the Board of Trustees at the March 3, 2022 meeting for their approval.
