## AN ORDINANCE AMENDING TITLE 3, CHAPTER 35 OF THE LOMBARD VILLAGE CODE IN REGARD TO NON-VILLAGE RESIDENT SENIOR CITIZEN REGIONAL TRANSPORTATION AUTHORITY (RTA) PASSES

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 3, Chapter 35 of the Lombard Village Code is amended by adding new Section 35.57 thereto, which shall read in its entirety as follows:

"§ 35.57 NON-RESIDENT SENIOR CITIZEN RTA PASSES

The fee for the processing and issuance of a non-Village resident senior citizen Regional Transportation Authority (RTA) free ride pass shall be five and no/100 dollars (\$5.00)."
