This agreement is made this 8<sup>th</sup> day of January, 2015, by and between, and shall be binding upon, the Village of Lombard, an Illinois municipal Corporation hereinafter referred to as (the "Village") and HD Waterworks Supply of Carol Stream, IL hereinafter referred to as (the "Contractor").

Witnesseth That in consideration of the mutual promises of the parties delineated in the Contract Documents, the Contractor agrees to sell and the Village agrees to pay for the following described items as set forth in the Contract Documents:

Water & Sewer System Supplies such as Pipe, PVC Fittings, Fire Hydrants, Castings, to be purchased on an as needed basis, in the amount not to exceed:

FY 2015 - \$42,000

  - b. The Contractor's Bid Proposal Dated December 19, 2014
  - c. Required Certificate of Insurance

The Village agrees to pay, and the Contractor agrees to accept as full payment for the items which are the subject matter of this Contract in an amount not to exceed \$42,000 in FY 2015 paid in accordance with the provisions of the Local Government Prompt Payment Act and the provisions of the Contract Documents.


