The FY 2011 budget includes replacement of Public Works unit # SM485, a 2004 Ford F550 dump truck. The bid results are as follows:

Public Works received three sealed bids. Freeway Ford was low bidder. The bid price for the new dump truck is \$53,390 less a trade-in allowance of \$23,500 equals a net bid price of \$29,890. The budgeted amount for this vehicle is \$37,000.

I recommend the B.O.T. award a contract to Freeway Ford of Lyons (IL) in the amount of \$29,890 for one new Ford F550 dump truck. I also recommend declaring Village unit #SM485 as surplus per the attached ordinance and authorizing its trade-in. Waiver of first reading is requested on this ordinance. Please submit this item to the Village Board for their consideration at the April 15, 2010 meeting.
